## **RESOLUTION 1**

### **Acknowledging the Accomplishments of President Donald J. Trump**

**WHEREAS**, President Trump, through executive orders, Congressional Review Act Resolutions and over 860 withdrawals and removals of regulatory actions, has reduced regulatory mandates on Americans;

**WHEREAS**, President Trump has appointed two conservative Supreme Court Justices and over 200 conservative federal judges;

**WHEREAS**, President Trump has instituted criminal justice reform and has judiciously pardoned certain citizens and commuted the unfair sentences of others;

**WHEREAS**, The energy policies of President Trump have unleashed the oil and gas production in the United States, making the U.S. a net exporter of energy; and

**WHEREAS**, President Trump increased individual freedom with the repeal of the individual mandate in the Affordable Care Act;

## **RESOLUTION 2**
